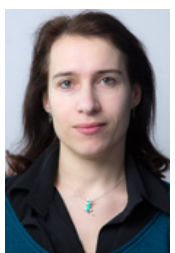
Keynotes



Martin Paul Eve is Professor of Literature, Technology and Publishing at Birkbeck, University of London, UK. He is the author of four books, including *Open Access and the Humanities: Contexts, Controversies and the Future*, published open access by Cambridge University Press. Mikael Laakso is Associate Professor of Information Systems Science at Hanken School of Economics, Helsinki, Finland. He has been researching the changing landscape towards openness in scholarly publishing by studying combinations of bibliometrics, web metrics, business models, science policy, and author behaviour for close to 10 years. In addition to research he is also active in open access advocacy as part of national and international working groups, most recently joining the H2020 Commission Expert Group: Future of Scholarly Publishing and Scholarly Communication.



Sabina Leonelli is Professor of Philosophy and History of Science at the University of Exeter, UK, where she co-directs the Centre for the Study of the Life Sciences and leads the Data Studies research strand. She is a member of the European Open Science Platform, representing the Global Young Academy, and a key expert for the EU Mutual Learning Exercise on Open Science. Her research focuses on the philosophy of data-intensive science and the ways in which the open science movement is redefining what counts as research and knowledge across research environments. Her book *Data-Centric Biology: A Philosophical Study* appeared in 2016 with Chicago University Press.



Katharina Rieck holds a Master's degree in Austrian Studies with a specialization in linguistics from the University of Vienna and a Master's in Library and Information Studies from the Humboldt-Universität Berlin. She joined the Austrian Science Fund (FWF) in 2014 where she is responsible for Open Science and manages the FWF's Peer-Reviewed Publications programme and the Open Research Data Pilot. Katharina is a member of Open Knowledge Austria and the Open Access Network Austria, and co-authored the *Recommendations for the Transition to Open Access in Austria and The Vienna Principles: A Vision for Scholarly Communication in the 21st Century*.

Vidar Røeggen is Senior Adviser at The Norwegian Association of Higher Education Institutions (UHR). This organization also holds the secretariat of The National Board of Scholarly Publishing (NPU), responsible for the administration and development of the Norwegian Publication Indicator. UHR has been commissioned by the Ministry of Education and Research to establish a permanent Publication Committee and Vidar Røeggen is Secretary of this committee. He is educated in political science at the University of Bergen and has worked 15 years as editor at the Norwegian publisher Universitetsforlaget.
